- **The Australian Federation of Ukrainian Organisations** is a peak body who promote, initiate, plan, direct and represent key facet's of community life in Australia.
- We represent 22 peak Ukrainian organisations in Australia such as churches, state community organisations, youth and women's organisations,

Aims

- The AFUO works to promote a positive image of the Australian Ukrainian community, encouraging its members to maintain religion, language, culture and heritage whilst being active members in the broader Australian community.
- The AFUO also maintains strong links with the Australian & Ukrainian Government, Ukraine and the Ukrainian Diaspora.

The Ukraine Crisis Appeal was formed by the AFUO in 2015 in response to Russia's 2014 invasion and war in Ukraine. Partnering with **Rotary Australia World Community Service (RAWCS)** and **Caritas Ukraine**

How does the Australian Federation of Ukrainian Organisations Humanitarian Aid Initiatives Committee (HAIC) work?

AFUO - Humanitarian Aid Initiatives Committee (HAIC)

- In conjunction with partners in Ukraine and our community establish needs and source a solution
 - Substantiate need and project integrity, budget, complete due diligence and establish KPI's and outcomes
 - Project considerations are based on urgency, greatest number of recipients, long-term benefit and partnering entity
 - AFUO HAIC Chair makes recommendation to the AFUO board.
 - ❖ **All projects or aid are reviewed and sanctioned by AFUO and then funding is approved**
- Rotary Australia World Community Services (RAWCS) work closely with HAIC and provide advice and support of programs
 - Weekly or daily contact is made, and monthly meetings are held with all stakeholders to track progress and assure the projects still satisfy current needs
 - RAWCS and AFUO regularly review project expenditure
 - Project managers provide HAIC regular progress reports which are measured against KPIs
 - Project recipient testimonials, photos and videos substantiate the programs
 - Regular visits to all programs are made by AFUO directors
